



**HFCL records 42 pc rise in net profit to Rs 75 crore, revenue declines 5 pc**

New Delhi, Jul 26 (PTI) Reliance Industries-backed Himachal Futuristic Communications Limited (HFCL) recorded a 42 per cent rise in its net profit at Rs 75.56 crore in the April-June quarter of FY2023-24, up from Rs 53 crore in the year-ago period, according to a BSE filing.

Its revenue declined 5 per cent to Rs 995 crore from Rs 1,051 crore in the last fiscal around the same period, according to the filing.

Net profit dropped 4 per cent sequentially from Rs 79 crore in the March quarter, while its revenue took a 31 per cent plunge from the previous quarter. The company had recorded Rs 1432 crore in revenue in Q4FY23.

Mahendra Nahata, Managing Director of HFCL said, "During Q1FY24, we have significantly increased revenues from international business to Rs 176.23 crores witnessing a growth of 156 pc on a Y-o-Y basis.

"HFCL's strategy to focus on increased revenue from products, expand its capacities and tap into new geographies has resulted in an increase in the product revenue share to 67pc in Q1FY24 as compared to 59pc in the same quarter last year."

The company has signed a two-year memorandum of understanding (MoU) with Bharat Electronic Limited, India's largest defence PSU for defence, telecom and railway sectors, he added.

## ■ HFCL Reports 42% Rise in Profit in Q1



**MUMBAI** HFCL, an Indian telecom equipment and cable maker, reported a 42.3% year on year increase in net profit for the quarter ended June 30, helped by efficient business practices, the company said Wednesday. HFCL's profit rose to ₹75.56 crore in the first quarter of the current fiscal as compared to ₹53.1 crore in the same quarter last year. Revenue from operations came in at ₹995.19 crore, 5.3% lower on-year than ₹1051.02 crore reported a year ago. However, revenue dipped 30.6% sequentially while its EBITDA and net profit saw 5.08% and 3.97% drops on-quarter, respectively.


