HFCL Limited has announced its unaudited financial results for the quarter and nine months ended December 31, 2023. On a standalone basis, the company reported quarterly revenue of Rs 9.54 billion, earnings before interest, taxes, depreciation, and amortisation (EBIDTA) of Rs 1.46 billion, profit before tax (PBT) of Rs 1.03 billion and profit after tax (PAT) of Rs 779.2 million.

For the nine months ended December 31, 2023, the company reported consolidated revenue of Rs 31.38 billion, EBIDTA of Rs 4.72 billion, PBT of Rs 3.04 billion and PAT of Rs 2.28 billion as against revenue of Rs 33.10 billion, EBIDTA of Rs 4.97 billion, PBT of Rs 3.21 billion and PAT of Rs 2.39 billion for nine months ended December 31, 2022.

In addition, for the nine months ended December 31, 2023, the company reported standalone revenue of Rs 28.36 billion, EBIDTA of Rs 3.86 billion, PBT of Rs 2.59 billion and PAT of Rs 1.94 billion as against revenue of Rs 30.72 billion, EBIDTA of Rs 4.02 billion, PBT of Rs 2.72 billion and PAT of Rs 2.03 billion for nine months ended December 31, 2022.
