HTL also manufactures key raw material for OFC such as Aramid Rods, Fiber Reinforced Plastic Rods and Impregnated Glass Fiber Reinforcement and provides electrical wiring interconnect solutions for the Aerospace & Defence and Automotive & Industrial sectors.
